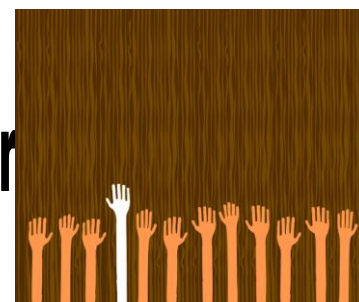
Golf Tournament personnel are "still straightening out finances" and Kate will contact Andy Lujan of the Booster Club to finalize proceeds.
